

Aegon Asset Management Swaps Disparate ESG Engagement Workflow for FactSet's Research Management Solution

THE CHALLENGE

Working with two distinct methodologies in two different countries, the Responsible Investment (RI) team at Aegon Asset Management began to feel the strain of not having a common strategy or platform for their growing commitment to ESG engagement. Between the difficulty in seeing each other's work, separately tracking engagement progress, and a general lack of transparency, they knew they needed a more cohesive and intuitive solution than their current Excel-based method—but the requirements didn't stop there. To maintain their existing research and ensure data continuity, the RI team needed to find a solution that kept and stored their historical notes. Facing these two main challenges—disparately tracking research and retaining past work—brought possibly the biggest challenge among them all: the risk of change.

THE SOLUTION

Recognizing the main Investment team at Aegon has been successfully using FactSet's Internal Research Notes (IRN) for years, some data-driven members of the RI team showed interest in learning how FactSet could help optimize their increasingly important ESG engagement workflow.

Considering all concerns, FactSet's team explained to Aegon how adopting IRN would not only help combine differently formatted workflows with the ability to regularly revisit and refresh, but would also initiate a historical research note migration. IRN provides high flexibility to maintain consistency across research process changes. It promotes collaboration in a centralized location to log research over time. And most importantly, it's easier than they expected.

Before and during implementation, FactSet's dedicated consultants collected requirements to build a tailored ESG engagement workflow using the team's proprietary language on ESG-related themes and parameters. IRN bridged the geographical gap between Aegon's RI teams who were using Excel-based templates in different ways; now, they have the connection and visibility to work in sync while honoring the distinct benefits of each team's original process.

Simultaneously, FactSet began the transition of the team's engagement historical notes by manually collecting and loading over 6,500 research notes into IRN. This process ensured no continuity breaks and allowed the RI team to hit the ground running with the new ESG engagement workflow. "Our engagement history is invaluable," says Miranda Beacham, Head of UK Responsible Investment. "We have been active in this space for decades and the reality is that many engagements with companies can span over many years. It is important to have the context of previous conversations to understand where the company has come from and what is achievable in the future. On top of tracking ESG engagements and storing fundamental internal research, IRN helped to integrate other workflows such as proxy voting and sustainability-related research into the investment process.
